The Chaparral Park General Store or employees of said business cannot be held responsible or liable for any vandalism, malicious mischief or acts of God that may occur to any items or possessions while parked in the Chaparral Park General Store storage areas or on store grounds.

- \_\_\_\_\_ (Initials) A NEW contract must be signed and initialed each and every year for each vehicle stored.
- \_\_\_\_\_ (Initials) Any vehicles in storage without a current contract will owe the monthly rate plus late fees.
- \_\_\_\_\_ (Initials) You may not "LOAN OUT" your storage space or key to anyone.
- \_\_\_\_\_ (Initials) Please respect other property in the storage area, do not block other items or the entry area, do not remove anything that does not belong to you, do not destroy anything.
- \_\_\_\_\_ (Initials) No repairs may be performed in the storage area.
- \_\_\_\_\_ (Initials) Only the items listed in the storage contract may be placed in the storage area.
- \_\_\_\_\_ (Initials) Do not leave storage area unlocked.
- \_\_\_\_\_ (Initials) No overnight camping allowed in storage area.
- \_\_\_\_\_ (Initials) Nothing may be stored on the ground around your unit.
- \_\_\_\_\_ (Initials) Theft or vandalism will not be tolerated and if you are caught doing so your item will be removed from storage immediately and you could face criminal charges.
- \_\_\_\_\_ (Initials) Storage fees are due for each month that your item is in storage until you notify the store in writing that you wish to terminate your contract. **IF NO WRITTEN NOTICE IS GIVEN UPON REMOVAL IT WILL BE ASSUMED IT IS STILL IN STORAGE AND THE MONTHLY STORAGE FEE AS WELL AS LATE FEES WILL ACCRUE UNTIL WRITTEN NOTICE IS GIVEN.**
- \_\_\_\_\_ (Initials) Any fees that are late by 10 days or more will result in a lock being placed on your item(s) until all fees are paid and up to date. The boot removal fee is \$50.00
- \_\_\_\_\_ (Initials) I understand I am responsible for any costs incurred in collecting unpaid fees and/or disposal of abandoned property. Abandoned property is defined as any item that is overdue by 90 days.
- \_\_\_\_\_ (Initials) Unit number must be posted on hitch or tongue of trailer.
- \_\_\_\_\_ (Initials) If we have to contact you (i.e. phone, email or postal service) there will be a processing fee of \$50 assessed in addition to late fees.
- \_\_\_\_\_ (Initials) Other than paying your bill over the phone all correspondence re: storage must be in writing or email.

Up to 10 days late: \$10.00 11-20 days late: \$15.00 21-30 days late: \$20.00 30 days +: \$50.00 each month
